

## OFFICIAL CONTEST RULES

**FOR WPXC, WFRQ, WHYA, WKFY operated by Coxswain Media, LLC.  
(hereinafter referred to as “Station”)**

*“Thomas Tick & Mosquito Spray Prize Surprise”*

### **Section 1** **Contest**

- a. The Station, operated by Coxswain Media, LLC., is promoting a contest beginning Monday, April 25, 2022 and ending on Friday, June 8, 2022. Station may terminate contest at any time or change dates and locations in its sole and absolute discretion.
- b. Potential qualifiers will listen to Station for “Cue to Call” from announcer. Once announced, the correct caller through is qualified to win that week’s “Prize Surprise”. (See Attachment A for list of prizes)
- c. A new winner will be selected at random from pool of previously determined qualifiers on Fridays through May 10, 2024.

### **Section 2** **How to Qualify**

- a. No purchase is necessary.
- b. Qualifiers must be 21 years of age or older to participate.
- c. When listeners hears the cue/solicit to call they will call Station at stated phone number and the correct caller, if eligible, will be qualified to win that week’s “Grand Giveaway” prize package.
- d. Listeners may qualify once per week but can qualify weekly. If the listener wins, standard prize protocol applies and they will be required to wait one calendar year before being eligible to win on Station again.
- e. Contest is open to all U.S. residents. All employees, agents, successors, interns, and assignees of Coxswain Media, LLC., employees of other radio or television stations and members of their immediate families are ineligible. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws", or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension and any other persons residing at the same household whether or not related. Participants and winner(s) must be U.S. residents.
