1.	16	CodComm Inc. provides all contest winners, and any visitors of the stations the opportunity to tour the radio stations and talk with the staff. During this time, careers in broadcasting are discussed and visitors are educated about the broadcasting industry. The tour includes

		information about how the broadcasting industry strives to serve its local community. Visitors are asked to give their opinions as to what the hottest topics in the local community are.
2.	16	Broadcasted announcements on WFRQ, WHYA, WKFY and WPXC to disseminate EEO information to potential recruitment sources, and to be notified when full time openings occur at CodComm Inc. These announcements were also published on CodComm's website: http://capecodradio.com
3.	7	Participated and sponsored a student in the 2021 Massachusetts Broadcasters Association Student Broadcaster Scholarship program. This program encouraged students who are interested in careers in broadcasting to apply for a \$2,000 scholarship towards degrees at colleges and universities offering degrees in radio and television broadcasting. The "winning" applicant was chosen after reviewing 25 qualified students.
4.	13	Codcomm has an ongoing affiliation agreement with the Project Forward Group at Cape Cod Community College. In 2021, CodComm announcer Mina Greene has an instructor for this program and has been involved in the development and ultimate success of these mentally handicapped individuals. One such graduate (Conor McGoff) is currently employed at CodComm and has a vital role in the production of weather reports and the morning show! Tours, guides and tutoring is ongoing in association with this project.
5.	3	Participated in the Massachusetts Broadcasters Association's Virtual Job Fair which concluded on October 29, 2021 and resulted in the collection of 5 resumes. Those resumes represent the potential of future opportunities in the position of Radio and Digital Sales.
